

**ORDINANCE NO. 2015-02**

**AN ORDINANCE ANNEXING LANDS FROM  
THE TOWN OF DUNN  
TO THE VILLAGE OF MCFARLAND  
(McFarland School District Property)**

The Village Board of the Village of McFarland do ordain as follows:

**WHEREAS**, a proper petition having been presented seeking direct annexation by unanimous approval, pursuant to Wis. Stats. § 66.0217(2), of the property legally described on Exhibit "A" attached hereto to the Village of McFarland, Wisconsin; and

**WHEREAS**, the signatories on the petition constitute all of the owners of land in the area proposed to be annexed and all resident electors within said property; and

**WHEREAS**, a scale map of the land proposed for annexation is attached hereto as Exhibit "B" and;

**WHEREAS**, the current population of the annexed property is zero; and

**WHEREAS**, pursuant to Wis. Stats. §66.0217(14)(a), said property is currently exempt from property taxation so that the Village is not required to make revenue sharing payments to the Town of Dunn under either the Statute or in Section 4 of the existing Boundary Agreement between the Village of McFarland and the Town of Dunn;

**NOW, THEREFORE**, the above -described property is hereby annexed from the Town of Dunn to the Village of McFarland; and




